# **Scoutmaster Report**

Mr. Davis reported there was no May campout. The Patrol Leaders Council met to perform their annual planning for the next scout year. They also discussed the plan for the summer and what they would like to do this summer. The Governor has lifted the restrictions on youth activities and there has been no word from council prohibiting the troop from resuming activities.

Summer activities the PLC is requesting, and Mr. Davis is looking at include Treehoppers as a day trip and not a campout, Pool Party at Mr. Davis' residence, Night Bowling, Top Golf to work on the golf merit badge, and scuba diving.

The campouts they are looking at for next year include Weeki Wachi snorkeling, Beaumont Farm Horseback riding, Fishing, MacDill AFB in the winter, Florida Caverns or Providence Canyon MLK weekend, BMX, Shotgun shooting, Patrick AFB/NASA, Aquatica/Ft. Wilderness, and Washington DC in the summer.

Initial review of the budget does not appear to necessitate a change in dues for next year. With the crossover scouts we now are at 37 Scouts.

#### Gifted Trailer

Mr. Knoop sent an email to our Chartered Organization Representative asking if there is any process, we need to follow to seek approval from the church. Mr. Hruska advised that when the last trailer was purchased there was nothing the church required, and they were able to register the trailer.

Mr. Knoop reminded everyone that Mr. Davis is approaching the end of his three-year term and we are in need of an Adult to replace him and requested if anyone is interested to please let us know. Mr. Davis is not leaving and would be there to support them.

Mrs. Van Sickle informed us that she met a Dive Instructor from Dive West who is also a merit badge counselor in Hernando County. He let her know that they will be holding a scuba camp over the summer. It is a five-day camp from 8:00 am - 5:00 pm. Their facility has everything needed for the scouts to obtain their scuba certification and merit badge, including their pool and grotto. The cost of the camp would be \$369 per person and has a maximum capacity of 8 individuals. Mrs. Van Sickle advised if we had an entire group of 8 there may be a discount on the cost per person.
